



2020-2021 FINANCIAL ASSISTANCE APPLICATION GUIDELINES

Financial assistance is available for students who desire to join First Tee - Aiken but are unable to pay fees for golf and life skills classes and activities. Each family or individual must meet the eligibility guidelines in order to receive financial assistance. If your family does not meet the income eligibility guidelines, but is currently experiencing extenuating circumstances, complete the Financial Assistance Application AND explain your particular circumstances for consideration. Granting of assistance is based on total family income level (see chart below).

Application Procedure:

- Financial Assistance Applications must be submitted to First Tee - Aiken with proper documentation anytime prior to or during registration.
- All applicants will be notified of their application status approximately a week prior to the beginning of classes.
- Incomplete applications will not be considered. All information will be kept confidential.
- Application for and/or approval of financial assistance does not guarantee a space in a specific class.
- You must have an approved Fee Scholarship Application on file prior to requesting an Annual or Seasonal Fee Scholarship.
- Renewal of the Financial Assistance Application is required at the beginning of each calendar year.

Family Income

Total annual family income includes income from all of the following sources before deductions for taxes, insurance premiums, bonds, and **other** employee deductions:

- All wages and salaries of working family members
- Self-employment income
- Social security
- Public assistance or welfare payments
- Alimony or child support payments
- Any other cash income

Your child may qualify for an Annual or Seasonal Fee Scholarship if your annual household family income falls within the limits on this chart.
